Can it really be that it has been 2 months since the 2nd Annual Autumn Soiree and Silent Auction? What an amazing evening it was. 200 people turned out to an evening of great food, music, and fellowship in the elegant San Diego Symphony Hall. Honorary Chair, Councilmember Donna Frye spoke and shared words of encouragement for our work in the community. There was the rousing Live Auction with Joe Slevcove and his Surfing Monkey!

A special thank you to our TACO board President, Lois Case and First Church Council member, Rosemary Spruce for their willingness to lead this event. Without their leadership the event would not have happened.

We received sponsorship from several sources to make this event possible: Carl Friedemann, Ameriprise Financial, "Energy

for Others", San Diego National Bank, & Washington Mutual.

More than \$12,000 were raised after expenses paid, and these funds were matched with a gift from Rev. Ted and Marietta Johns. This makes our grand total \$24,000! Thank you to everyone who so graciously shopped and bought and helped to build this fund that will be used in the coming year for our operational expenses.

Further in this issue, you will find information about other ways in which you can support TACO with a financial gift. As you may know if you have volunteered with us, we have very little to no overhead costs. We pay a tithe to our partners at First Lutheran Church to cover some of our expenses. ## Grants, donations more vital than ever as TACO matures

Our TACO family of volunteers and donors is the heart of our organization; they're the people who make our mission happen every day. But did you ever wonder what else keeps us ticking?

In a word—grants. Big and small, long-term and short, grants cover so much of what we do. And assuring coverage

of our various programs through multiple funding sources requires the skills of an accountant, advocate and juggler. Fortunately we have all three in Director Jim Lovell and the TACO board.

However, three of our major funding sources, grants from Johnson & Johnson Foundation, Wheat Ridge Ministries, and

Alliance, are scheduled to end in the coming year. The board has hired a grant writing specialist to seek out new funding sources even as existing grants terminate. And as TACO matures, the board is working to develop sustainable funding sources so we won't be quite as

dependent on grants to fund program expenses, equipment and most importantly, staff positions.

## Ready for Souper Bowl Sunday?

TACO and First Lutheran Church will participate again this year in the **"Souper Bowl of Caring"** on Superbowl Sunday, **February 3, 2008**.

A special collection at both services this Sunday will be earmarked for TACO's feeding programs. Look for our youth volunteers, who will be gathering offerings in the biggest soup pots our kitchen can supply!

One hundred percent of donations collected go directly to TACO to fight hunger.

This national event began in 1990 with one youth group in Columbia, S.C. and a simple prayer: Lord, as we enjoy the Super Bowl football game, help us be mindful of those who are without a bowl of soup to eat. Its mission is to become the largest youth-led ministry to raise awareness and fight hunger.



**TACO TAX TIP:** Recent pension legislation now allows taxpayers who are 70 ½ or older to contribute as much as \$100,000, tax-free, directly to qualified charities (such as TACO)

from IRAs.

This applies to otherwise taxable IRA distributions (either traditional or Roth) only for 2007. You'll need to itemize your deductions, but this law should reduce taxable income. See your tax professional for information.



## Christmas in July nears goal, needs last-minute elf help

Christmas Eve is just around the corner, and that means another joyful celebration of giving and receiving on the TACO patio.

The annual "Christmas in July" fundraiser has so far collected \$3,500 of the \$5,000 needed to purchase 250 sleeping bags and heavy-duty rain tarps to give to our guests during the holidays.

This fundraiser is an annual tradition that's much anti-

pated by volunteers and guests alike. Sleeping bags and tarps will be wrapped and distributed at the Friday morning meal on December 21.

## How to support TACO? Bet you didn't think of ...

Many people ask how they can support our programs. In addition to volunteering at our regular weekly meals, here are just a few creative ideas:

**E-scrip:** Purchase e-scrip and you'll be able to donate a portion of your purchases at dozens of participating merchants directly to TACO. Here's how it works: go to <http://www.escrip.com> and register your credit cards, check cards, or store cards (such as a Vons card).

Now, every time you use that card to make a purchase at Vons, or Safeway, or Henry's, and many others (a list is available at their website), a portion of your purchase will be donated to the charity of your choice.

TACO is one of the many charities enrolled in the e-scrip program. To support TACO, simply type in "Third Avenue Charitable Organization" when the site asks for your group name after you click on "sign up," or enter the group ID, which is 9557002. All contributions are tax deductible.
